

Fund Opportunities

Unrestricted Endowment Fund: The St. Hilary Parish Foundation Unrestricted Endowment Fund established in 1976 supports the needs of St. Hilary School and Church.

St. Hilary School Endowment Fund: The School Endowment Fund supports the capital and operating needs of the school as well the students and educational staff of St. Hilary School. This may include but is not limited to tuition, scholarships, salary, and benefits for the educational staff or any capital or operating need of St. Hilary School.

St. Hilary Parents' Teacher Salary Fund: The St. Hilary Parents' Teacher Salary Fund supports the educational staff at St. Hilary School and other school related concerns. This could include but not be limited to salary, benefits, and continuing education. Teacher Salaries and benefits account for approximately 85% of the school expenses.

Tuition Assistance/Scholarship Fund: The Tuition Assistance/Scholarship Fund provides tuition assistance and scholarships to students attending St. Hilary School.

Kevin Thomas Neff Scholarship Endowment Fund: The Kevin Thomas Neff Scholarship Fund was established in Kevin's name to ensure that his memory is kept alive in our community. The scholarship managed through the Foundation is to be given to a 6th or 7th grade St. Hilary student, continuing their education at St. Hilary School who is determined by spiritual, academic, and social criteria, as set forth by the Neff family. Candidates must be well-rounded individuals who, in the face of any type of challenge, display an indomitable spirit and humor with strength, and portray a steadfast ministry with their faith. The scholarship is announced at the annual May Crowning Mass.

St. Hilary School Technology Fund: The Technology Fund supports technology needs at St. Hilary School.

Arts/Musical Theatre Fund: The Arts/Musical Theatre Fund supports the Arts and Musical Theatre at St. Hilary School.

Alumni Fund: Alumni Funds are named for each graduating class and support capital and/or operating needs of St. Hilary School.

PSR Fund: The PSR Fund supports various needs of the St. Hilary PSR Program.

Family Named Fund: A Family Named Fund is a fund named by a family as an unrestricted or restricted fund within the St. Hilary Parish Foundation. An unrestricted fund is a fund that is designated to be used for whatever is necessary within the church or school. A restricted fund is a fund that is to be used for a specific purpose such as for school scholarships, technology, community outreach, or music ministry, just to name a few. To establish a Family Named Fund, the fund must reach at least \$5,000, which can be committed in a single donation or in payments made over time. The following Family Named Funds have been established: *Mary Jean Carroll School Endowment Fund, Mary & Charles Booth Community Outreach Fund, Dorothy L. D'Andrea Fund, Edward Gilbert Family Scholarship Fund, Jean & Joseph Hauser Fund, Kyle Family Fund, Salma & Sam Gibara Fund, Delaney Family Fund, Westover Family Fund.*
